11 CSR 45-40.040(2) states, "All licensed operators of and applicants for fantasy sports contest operator (FSCO) licenses issued by the commission shall have a continuing duty to disclose in writing, within ten (10) calendar days for an applicant and thirty (30) calendar days for a licensee, any material change in the information provided in the application forms and requested materials submitted to the commission. Any change in information that is not material must be disclosed to the commission during the licensee's next subsequent application for license renewal."

In accordance with 313.935.3(1), RSMo, the renewal fees for a FSCO license are due by November 1 of each year and are as follows:

- \$5,000 Net revenues of two million dollars (\$2,000,000) or more from the previous calendar year.
- \$2,500 Net revenues of less than two million dollars (\$2,000,000) but greater than one million dollars (\$1,000,000) from the previous calendar year.
- \$1,000 Net revenues equal to or less than one million dollars (\$1,000,000) but greater than two hundred fifty thousand dollars (\$250,000).

No renewal fee is due from those operators with net revenues of two hundred fifty thousand dollars (\$250,000) or less from the previous calendar year.

Net revenue, for all fantasy sports contests, is defined as the amount equal to the total entry fees collected from all participants entering such fantasy sports contests less winnings paid to participants in the contests, multiplied by the location percentage.

Location percentage, for all fantasy sports contests, is defined as the percentage, rounded to the nearest one-tenth (0.1) of one percent (1%) of the total entry fees collected from registered players located in the state of Missouri at the time of entry into a fantasy sports contest, divided by the total entry fees collected from all players, regardless of the players' locations, of the fantasy sports contests.
