PRELIMINARY ORDER FOR DISCIPLINARY ACTION

Comes now the Missouri Gaming Commission acting in its official capacity pursuant to 11 CSR 45-13.050, and states as follows:

- 1. The Missouri Gaming Commission (the "Commission" or "MGC") is a state commission created under Chapter 313, RSMo, 2016, with jurisdiction over gaming activities, including riverboat gambling activities, in the State of Missouri.
- 2. International Game Technology ("IGT" or "the Company") is a supplier of gaming machines, progressive systems, and casino management systems.
- 3. The Commission issued a Supplier license to the Company to provide gaming machines, progressive systems, and casino management systems, or other items directed by the Commission to a Class A or Class B licensee or to the Commission.
- 4. As the holder of a Supplier license, the Company is subject to the provisions of §§ 313.800 to 313.850, RSMo, and the regulations promulgated thereunder by the Commission.

STATEMENT OF FACTS²

- 5. On August 20, 2018, Lumiere Place Casino & Hotels (hereafter, the "Casino") received a shipment of four Electronic Gaming Devices (EGDs) from IGT. Two of the four EGDs received contained revoked game Critical Program Storage Media (CPSM).
- 6. MGC staff discovered the revoked CPSM on August 24, 2018.
- 7. The MGC Revocation letter, dated April 20, 2018, stated that the CPSM was revoked for a "game recall wheel position display error" and was initially reported to the MGC by IGT in an EGD Incident Report on April 12, 2018.
- 8. IGT admitted that the status of that program had not been correctly updated in its system, allowing the revoked program to be shipped to the Casino.

- 9. Under § 313.805(6), RSMo, the Commission may assess any appropriate administrative penalty against a licensee, including, but not limited to, suspension, revocation or penalties of an amount determined by the Commission.
- 10. Section 313.812.14, RSMo, states, in pertinent part, as follows:

A holder of any license shall be subject to imposition of penalties, suspension or revocation of such license, or if the person is an applicant for licensure, the denial of the application, for any act or failure to act by himself or his agents or employees, that is injurious to the public health, safety, morals, good order and general welfare of the people of the state of Missouri, or that would discredit or tend to discredit the Missouri gaming industry or the state of Missouri unless the licensee proves by clear and convincing evidence that it is not guilty of such action. The commission shall take appropriate action against any licensee who violates the law or the rules and regulations of the commission. Without limiting other provisions of this subsection, the following acts or omissions may be grounds for such discipline.

- (1) Failing to comply with or make provision for compliance with sections 313.800 to 313.850, the rules and regulations of the commission or any federal, state or local law or regulations;
- (2) Failing to comply with any rule, order or ruling of the commission or its agents pertaining to gaming[.]
- 11. Under 11 CSR 45-5.237(2), "critical program storage media shall be approved for use in the state prior to shipment and shall be shipped separately from electronic gaming devices unless otherwise approved in writing by the commission."

VIOLATIONS

- 12. The actions or omissions of employees or agents of the Company as described above constitute the shipping of revoked software to the Casino, which is a violation of 11 CSR 45-5.237(2).
- 13. The Company is therefore subject to discipline for such violations under §§ 313.805(6) and 313.812.14 (1) and (2), RSMo.

PENALTY PROPOSED

14. Under § 313.805(6), RSMo, the Commission has the power to assess any appropriate administrative penalty against the Company, as the holder of a Supplier license.

15. THEREFORE, it is proposed that the Commission fine International Game Technolo amount of \$2,500 for the violations set forth herein.	gy, the
