- 22 CHAIRMAN LEARA: Next item on the agenda
- 23 Interblock transaction. We'll just call it that.
- Mr. Grewach, you have the floor.
- MR. GREWACH: Yes. Rob Cantwell will be

- 1 presenting on behalf of his client. This is a
- 2 follow-up. This issue was discussed at the last
- 3 meeting. There were some questions that we would ask
- 4 more information from Mr. Cantwell's clients and he's
- 5 provided that, which you have on the dais.
- And so I would just call on Mr. Cantwell.
- 7 MR. CANTWELL: Chairman Leara,
- 8 Commissioners, Judge and staff, good morning. I
- 9 appreciate the opportunity to be before you today again
- 10 to discuss the Interblock transaction and a proposed
- 11 temporary approval for various elements of the
- 12 transaction.
- 13 My name is Robert Cantwell from the firm
- 14 Lathrop GPM and I represent Interblock and Oaktree and
- 15 its various funds in connection with this proposed
- 16 transaction.
- 17 In our last meeting, we went through the
- 18 details of the transaction. There was a lot of
- 19 complexities and there were some very good questions by
- 20 Chairman, yourself, and your Commissioners and the Judge
- 21 as well.
- 22 And we put in some work in the interim to
- 23 try to get you additional information, all very good
- 24 questions, mainly about what is above the economic
- 25 equity side of the proposed structure.

- 1 Hopefully we've given you some insight into
- 2 what resides over there. I'm not going to belabor the
- 3 matter, because I think I did a lot of that at the last
- 4 meeting, and your patience and your staff's
- 5 professionalism, again, is very much appreciated and
- 6 very impressive.
- 7 Missouri, there's no question, has more
- 8 information about this transaction than any other
- 9 jurisdiction. And, again, I really do believe the
- 10 questions were on point, focused on what our regulations
- 11 required. And so I appreciate the opportunity to get
- 12 you that information.
- 13 What I will say is, these approvals that are
- 14 required under our regulations as variances to get the
- 15 transaction to move forward on a timely basis, these
- 16 approvals are of a temporary nature. So the resolution
- 17 that's proposed to allow for this simply allows the
- 18 suitability investigation to go forward in connection
- 19 with the transaction close.
- 20 So if, during that suitability
- 21 investigation, through looking, let's say, above the
- 22 economic side on the equity structure at Oaktree Capital
- 23 Management, LP level, if it's determined by your, you
- 24 know, excellent investigative staff that some individual
- 25 or entity needs to fall into place in the suitability

- 1 investigation, whether as an applicant or more serious
- 2 investigation or interview, Oaktree is committed to
- 3 making all that available to you and your staff.
- 4 And in addition, just to reiterate from the
- 5 last meeting, if there were to become an issue -- and,
- 6 again, your staff would be the best to figure it out --
- 7 the -- unlike in some other circumstances, with this
- 8 supplier and this particular supplier, we are able to
- 9 exit from the state if that needs to be the decision
- 10 made by the Commissioners at any time in the future.
- 11 So I'm happy to answer any questions and
- 12 appreciate, again, your time and effort all the way up
- 13 until yesterday. So I really appreciate it.
- 14 CHAIRMAN LEARA: Thank you, Mr. Cantwell,
- 15 especially for being efficient and responsive to our
- 16 questions, as you mentioned, up through yesterday. So
- 17 it's been helpful and it adds a level of comfort to at
- 18 least go forward on a temporary basis.
- 19 But I will note, the waiver of institutional
- 20 investors, I don't think that's temporary, is it?
- MR. GREWACH: It's temporary to the extent
- 22 that there's a provision in the resolution and the rule
- 23 itself that the Commission can, at any time, with or
- 24 without cause, require any of the Oaktree entities to be
- 25 licensed.

- 1 CHAIRMAN LEARA: Okay. Fair enough.
- 2 MR. CANTWELL: So -- and to be clear on that
- 3 point, if there were to -- if there was to be a feeling
- 4 that Oaktree Capital Management, LP did need to file and
- 5 expose itself to suitability, again, that would probably
- 6 be an impossibility for that entity, but that's one way
- 7 for the Commissioners to sort of have a pressure release
- 8 valve on the entire structure and make its position
- 9 final.
- 10 CHAIRMAN LEARA: So I have a question or
- 11 two, but I'm going to let these other Commissioners go
- 12 first if they have any.
- Mr. Conway, Mr. Hane, Commissioner
- 14 Zimmermann, are you okay?
- 15 COMMISSIONER ZIMMERMAN: I am.
- 16 CHAIRMAN LEARA: Okay.
- 17 So I noticed -- and it may have been a
- 18 communication from either late yesterday or very
- 19 recently -- that you noted Oaktree is a public fund. Is
- 20 it a publicly traded company?
- MR. CANTWELL: Yes.
- 22 CHAIRMAN LEARA: It is a publicly traded
- 23 company and the fund is open to the public, also?
- MR. CANTWELL: Correct. It has two sort of
- 25 divisions, you could call them. One is the publicly

- 1 traded aspect, and then our column or our segment is in
- 2 the private equity side. So it's a private investment
- 3 fund with only certain participants allowed.
- 4 CHAIRMAN LEARA: Okay. That's all the
- 5 questions I have.
- 6 Anyone else?
- 7 Anything else to add, Rob?
- 8 MR. CANTWELL: Just, again, really
- 9 appreciate the professionalism. Your staff knows how to
- 10 investigate.
- 11 CHAIRMAN LEARA: All right. Thank you.
- Mr. Grewach, did you have anything to add
- 13 before we move?
- MR. GREWACH: I do not, Chair.
- 15 CHAIRMAN LEARA: Okay.
- 16 COMMISSIONER CONWAY: Can I ask Ed a
- 17 question? It seems that we are getting more requests
- 18 for variances for institutional investment in recent
- 19 years. Am I out of line there? Or prior to us assuming
- 20 these positions, has there been a continual request for
- 21 variance?
- 22 MR. GREWACH: I could not tell you that
- 23 without doing a little more research to look at the
- 24 volume. Many of the institutional investor waivers that
- 25 are presented to you are renewals that get renewed every

- 1 two years.
- So, now, the two on the agenda today are
- 3 new, but we'd have to go through and look through for
- 4 each institutional investor when it first applied. But
- 5 the reason that it comes up fairly often on the -- on
- 6 your agendas is because they do have to renew every two
- 7 years.
- 8 CHAIRMAN LEARA: Okay. Thank you.

- 20 investor. This would be Eagle Asset Management,
- 21 Incorporated.
- Mr. Grewach?
- MR. GREWACH: Thank you.
- Mr. Chairman, Commissioners, under Tab G, we
- 25 have a request by Eagle Asset Management, Incorporated

- 1 for a waiver for an institutional investor. The Eagle
- 2 Management is -- owns 5.69 percent of Everi Holdings
- 3 Incorporated, which is a licensed key business entity of
- 4 Everi Gaming Incorporated.
- 5 The company is a subsidiary of Raymond James
- 6 Financial, Incorporated, which provides financial and
- 7 investment services. Raymond James Financial,
- 8 Incorporated, is a publicly traded company.
- 9 CHAIRMAN LEARA: Any discussion?
- 10 Seeing none, I move for the approval of
- 11 Resolution No. 22-023 for waiver for Eagle Asset
- 12 Management.
- 13 Is there a second?
- 14 COMMISSIONER CONWAY: I'll second.
- 15 CHAIRMAN LEARA: Second, Mr. Conway.
- Any other discussion on the motion?
- 17 Seeing none, Angie, call the roll.
- 18 MS. FRANKS: Chairman Leara.
- 19 CHAIRMAN LEARA: Approved.
- 20 MS. FRANKS: Commissioner Conway.
- 21 COMMISSIONER CONWAY: Approved.
- MS. FRANKS: Commissioner Hane.
- 23 COMMISSIONER HANE: Approved.
- 24 MS. FRANKS: Commissioner Zimmerman.
- 25 COMMISSIONER ZIMMERMAN: Approved.

- 1 MS. FRANKS: By your vote, you've adopted
- 2 Resolution No. 22-023.
- 3 CHAIRMAN LEARA: Next item on the agenda,
- 4 No. H, State Street Corporation resolution.
- 5 Ed Grewach.
- 6 MR. GREWACH: Yes. We have State Street
- 7 Corporation's application for a waiver for an
- 8 institutional investor. They own 5.01 percent of
- 9 Aristocrat Leisure Limited, who is a licensed supplier.
- 10 State Street Corporation is a business which offers,
- 11 among other things, investment management services.
- 12 They are a publicly traded company.
- 13 CHAIRMAN LEARA: Any discussion?
- Yes, Mr. Conway.
- 15 COMMISSIONER CONWAY: Okay. Going back to
- 16 my original question on the previous one.
- MR. GREWACH: Yes.
- COMMISSIONER CONWAY: So we're -- the 5.01,
- 19 what is the minimum percentage level where they have to
- 20 ask for a waiver?
- 21 MR. GREWACH: Any company or any person that
- 22 owns more than 5 percent of a licensee needs to either
- 23 get licensed or get an institutional investor waiver.
- 24 So 5 percent is the mark.
- 25 COMMISSIONER CONWAY: So considering that

- 1 these are coming up in renewals, is there anything in
- 2 our regulations on the percentage? Does the staff feel
- 3 that the percentage is correct and accurate, Judge, or
- 4 has there been any consideration of an increase in the
- 5 percentage? If it's 5.01, I mean, it's close. So where
- 6 do -- where historically -- or where do you think we
- 7 should stand on that aspect?
- 8 MR. GREWACH: Well, we -- and I -- without
- 9 looking back to the history of the rule, I mean, it's
- 10 been the 5 percent for the entire time I've been here.
- 11 And to my knowledge, it's always been 5 percent. Every
- 12 state has some form of this. I -- you know, we have --
- 13 we can take a survey of other states and see where they
- 14 start.
- But the philosophy is that when you own some
- 16 percent of the company, then you're going to be in a
- 17 position to have some control over it. I remember
- 18 reading in the news about Mr. Boscoh owned a certain
- 19 percentage of Twitter and, you know, that gave him some
- 20 significant advantage to direct things.
- 21 So that's what the question is. What
- 22 percentage do you own? The 5 percent is just -- is a
- 23 number just selected. I mean, we can move it one way or
- 24 the other, depending on what the Commission would like.
- 25 If the Commission would like, we could certainly look

- 1 into that.
- We are actually looking at making some
- 3 changes to Chapter 4 of the entire licensing chapter in
- 4 our rules and we certainly could look into this at that
- 5 same time.
- 6 CHAIRMAN LEARA: I'll add a little bit to
- 7 that. So for this example that we're on now, State
- 8 Street is a mutual fund company and they have a
- 9 securities division. It's a Wall Street firm. And this
- 10 is likely going into one of their funds, is what it is.
- 11 While the influence of State Street has
- 12 no -- the management is likely to have zero desire in
- 13 getting involved and they just want to increase their
- ownership in Everi; is that correct?
- MR. GREWACH: That's what --
- 16 CHAIRMAN LEARA: Typically, the person that,
- 17 in theory, could have some control would be either the
- 18 portfolio manager of the fund that's -- whichever one is
- 19 acquiring 5.01 to 5.69 percent. Is that what they're
- 20 doing?
- MR. GREWACH: Yes. Yes.
- 22 CHAIRMAN LEARA: So -- but the -- there
- 23 again, the portfolio managers, there would be conflicts
- 24 of them trying to influence Everi Holdings. It's just
- 25 -- it's highly unlikely and that's why we'll see this.

- 1 But they'll have -- someone like State Street may have
- 2 600 mutual funds and five of their funds could have
- 3 ownership in numerous gambling operations that would
- 4 come before us on a repetitive basis. We'd have to see
- 5 for each one of those holdings -- is that right? -- the
- 6 waiver.
- 7 MR. GREWACH: That's correct.
- 8 CHAIRMAN LEARA: And we're not just giving
- 9 State Street a waiver, we're giving them a waiver on
- 10 this one position?
- 11 MR. GREWACH: Now, once we give it, they can
- 12 go up to 20 percent --
- 13 CHAIRMAN LEARA: That's right.
- MR. GREWACH: -- for this company.
- 15 CHAIRMAN LEARA: Right. So I think the
- 16 5 percent trigger is a good number, but I'm welcome to
- 17 have that discussion.
- JUDGE RICHARDSON: Chairman, Commissioners,
- 19 the other thing is, is on institutional waiver, you
- 20 know, they state, and it is part of the waiver, that
- 21 they will have no management control, that their
- 22 interest is passive only. So they couldn't exercise
- 23 that control even if they wanted to. It's part of the
- 24 waivers, that they would be passive only.
- 25 COMMISSIONER CONWAY: Okay.

- 1 CHAIRMAN LEARA: Okay. Any more on State
- 2 Street resolution?
- 3 Seeing none, I move for the approval of
- 4 Resolution No. 22-024.
- 5 And is there a second?
- 6 COMMISSIONER HANE: Second.
- 7 COMMISSIONER ZIMMERMAN: Second.
- 8 CHAIRMAN LEARA: Commissioner Hane, second.
- 9 Any other discussion?
- 10 Seeing none, Angie, call the roll.
