COMMISSION RESOLUTION NO. 23-084
REGARDING WAIVER OF LICENSURE
FOR INSTITUTIONAL INVESTOR

December 6, 2023

WHEREAS, AWM Investment Company, Inc. (“AWM”), has requested a waiver of licensure under 11 CSR 45-4.020 as an institutional investor; and

WHEREAS, AWM has stated that it may acquire interests in Century Casinos, Inc. (“Century”), a Missouri licensee, of five point four two percent (5.42%) but not more than twenty percent (20%); and

WHEREAS, AWM has affirmed that it may acquire these interests for investment purposes only and not for the purposes of causing directly or indirectly changes in the management, policies or operations of said licensee and that AWM has no involvement in the business activities of any licensee in which it holds or may acquire interest or any intention of influencing or affecting the affairs of any licensee with the stock that it now owns or may in the future acquire; and

WHEREAS, AWM has affirmed that in the event AWM subsequently develops an intention of controlling or participating in the management of any licensee, AWM will notify the Commission of said changes and refrain from participating in management or exercising such control until approved by the Missouri Gaming Commission; and


WHEREAS, A has complied and affirmed its willingness to conform to all disclosures and notices required by 11 CSR 45-4.

NOW, THEREFORE, BE IT RESOLVED, that the Missouri Gaming Commission grants AWM’s request to waive licensure requirements required under 11 CSR 45-4.020 for up to and including twenty percent (20%) ownership in said licensee.

BE IT FURTHER RESOLVED that the granting of this waiver in no way prevents the Missouri Gaming Commission at some future date, with or without cause, from requiring AWM to apply for and obtain licensure pursuant to 11 CSR 45-4. In such an event, failure to obtain licensure could result in AWM being required to divest all or part of their interest in a licensee or the loss of the licensee’s ability to do business in Missouri.

BE IT FURTHER RESOLVED that this waiver is for a period of two (2) years from the date of this Resolution, and it will be necessary for AWM Investment Company, Inc., to reapply for a waiver on or before sixty (60) days prior to the expiration of this waiver.
